- I agree to not interfere in any way with referees, opposing coaches or parents in any competition. It is my responsibility to allow the coaching staff of MHWC to resolve any conflict arising from a bad call by a referee or opposing parent heckling of myself or my wrestler.
- I agree to notify the coaching staff of any conflict between wrestlers within our team and that notification should be done in private and away from the athletes. I understand it is the MHWC Staff's place to resolve any such conflict.
